Why Study in the U.S.?

If you're thinking of studying in another country, you've probably already weighed the advantages and disadvantages of pursuing a program in the U.S. If you have a specific career choice in mind, you may have found a specialized program only offered at a select U.S. institution; however, you might still worry about whether you'll be accepted or if it's within your budget. Despite these honest concerns, it's important to think ahead and consider the flexibility of U.S. programs, as well as the many financial aid and award opportunities to help meet your future goals.


Interest in the U.S. as a study destination remains as strong as ever, with international enrollments at all all-time high. There are currently over 723,000 international students from over 200 places of origin studying at U.S. higher institutions, according to the most recent data from IIE's *Open Doors Report*. About equal numbers of students come to pursue undergraduate and graduate degree programs, with a smaller number of students coming just to study English or pursue other non-degree study. Business and management is the most popular field of study for undergraduates, while engineering is the most popular field among graduate students.

Almost two-thirds of international students in the U.S. (64 percent) come from Asia, with China, India and South Korea being the top places of origin.

So, what makes a student choose to study in the U.S.?

The Institute of International Education (IIE) has been conducting surveys since 2009 in cooperation with EducationUSA to gauge prospective students' attitudes and perceptions about studying in the U.S. Over 10,000 students in 20 countries have participated in the surveys to date, more than three-quarters of whom said that the U.S. was their first-choice study abroad destination.

These students were interested in the U.S. for its renowned high quality higher education system and wide range of academic options. Even students from countries that host large numbers of international students, such as the U.K., saw the U.S. as having a



wide range of schools and programs, a high quality higher education system, and many scholarship opportunities. Overall, students perceived a high degree of flexibility within the U.S. education system, where switching fields of study or transferring credits to another institution can be done with relative ease.

At first glance, budgetary constraints may seem overwhelming, but there are many financial resources available to help in your pursuit of U.S. study. While tuition may be expensive, the U.S. also has a wide variety of programs to help you finance your study—through both public and private organizations, as well as colleges and universities themselves. Data from *Open Doors* 2011 showed that while the main source of funding for international students to pay for college is personal and family funds, 37 percent of international students were funded by other sources, both U.S. and foreign.

Another option for undergraduates is to begin your studies at a community college, where tuition rates are lower, and transfer to a four-year college or university after two years. Your final degree will come from the four-year school and will be identical to a degree awarded to a student who studied there all four years. Community colleges host about 12 percent of all international students in the U.S.

IIE administers many scholarships and grants for international students (for more information, go to www.iie.org), but EducationUSA advisers in your own country can also help you find viable options
